# 1 Introduction

CrossMark is a new type of cross-platform benchmark that measures system performance and responsiveness using common and relevant workloads that model the performance characteristics of real-world applications. CrossMark uses a combination of open source and proprietary workloads to assess system performance scores in the areas of Productivity, Creativity and Responsiveness. CrossMark installs quickly and gives results in only a few minutes. The overall performance score is designed to track those of SYSmark 25. CrossMark also allows the comparison to be made across a range of operating systems.

CrossMark gives commercial and government IT decision makers, media, channel buyers, consultants, and system and component designers and manufacturers, government and non-government agencies and standards bodies an objective, easy-to-use tool to evaluate PC performance across the wide range of activities that a user may encounter.

CrossMark is designed for those who want to evaluate and compare desktop, notebook, 2-in-1 and tablet computers for evaluating system performance across platforms.

Additional features and highlights of CrossMark include:

- **Cross-Architecture System Benchmarking** – Runs on Windows, Android (ChromeOS, Not Supported), iOS and macOS to assess the performance, regardless of the operating system. More platforms will be added in the future.
- **System Benchmark Modeled on Real Applications** – Measures common user performance by modeling real applications using open source and proprietary workloads.
- **Realistic Performance Scaling** – Scales similarly to real applications across CPU frequency, cores and threads, system memory, storage, GPU and other capabilities.
- **Lightweight Install with Intuitive Interface Supporting Touch Screens** – Streamlined user experience beginning with a quick installation process of less than a minute, necessitating less than 1GB of storage – users can begin benchmarking with a single click, or tap of their screen.
- **Automated Run Time Support** – Provides the option to automate benchmarking tests to simplify and streamline system measurement.
- **Online System Performance Database** – Supports online results submission to enable real-time device comparison and evaluation.

CrossMark builds upon BAPCo's 30-year history of building benchmarks to evaluate platform technologies. Benchmarks designed by BAPCo are the result of cooperative development between member companies representing the breadth of the computing industry.

This document describes the methodologies employed in the development of CrossMark. For detailed instructions on how to install and run CrossMark products, please refer to the documentation provided on the installation media and/or the BAPCo web site ([www.bapco.com](http://www.bapco.com)).

## 2 BAPCo Development Process

BAPCo creates benchmarks in accordance with the BAPCo Development Process, a set of milestones and checkpoints collaboratively developed and agreed upon by the BAPCo membership.

### 2.1 Milestone Overview

The BAPCo development process is divided into six major phases (Initialization, Design and Planning, Implementation, Validation, Characterization and Launch). Each phase consists of a series of milestones, some of which may be worked on concurrently.

The membership must vote to close each milestone. Once all the milestones within a phase are complete, the membership must vote to exit the phase and enter the next phase. BAPCo members work in a collaborative process where decisions regarding products are made by majority vote rather than unanimously.

The following is the list of the development phases and the corresponding milestones.

## 2.2 Usage Model, Sub Scenario, and Scenario Selection

In milestone 7 of the BAPCo Development Process, the committee chooses PC usage models for inclusion in the benchmark. CrossMark is based on the same usage models as SYSmark 25, which is an application-based benchmark available on x86\_64 Windows\*.

Similar to SYSmark 25, CrossMark consists of seven sub-scenarios: – Document Editing, Spreadsheets, Web Browsing, Photo Editing, Photo Organization, Video Editing, and Responsiveness, detailed below:

- Document Editing

The Document Editing sub scenario models productivity usage of email creation/management, PDFs, presentations, and word processing.

- Spreadsheets

The Spreadsheets sub scenario models scientific simulations, forecasting, modeling within a spreadsheet application.

- Web Browsing

The Web Browsing sub scenario models website loads, web compute, and tab switching within a web browser.

- Photo Editing

The Photo Editing sub scenario models photography editing and post processing.

- Photo Organization

The Photo Organization sub scenario models photo cataloging and machine learning based image recognition.

- Video Editing

The Video Editing sub scenario models nonlinear video editing and composite video rendering for use in social media and other online venues.

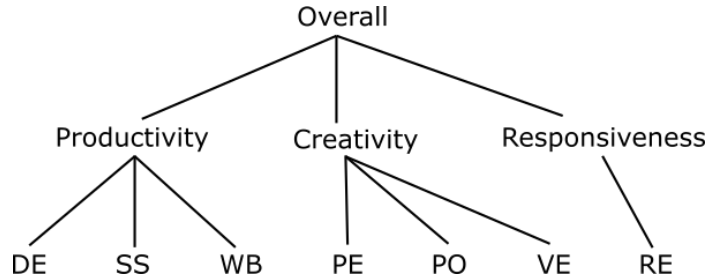
- Responsiveness

The Responsiveness sub scenario models usages where the ability of the system to react quickly to the user's input impacts the experience of using the system (i.e. – users want to feel like the system responds smoothly and quickly). Some modeled usages include: application launches, file launches, and multi-tasking.



## 2.3 Scenario Grouping

The sub scenarios are grouped according to the descriptions below, as illustrated by Figure 1.

### 2.3.1 Productivity

The Productivity scenario contains Document Editing, Spreadsheets, and Web Browsing sub scenarios.

### 2.3.2 Creativity

The Creativity scenario contains Photo Editing, Photo Organization, and Video Editing sub scenarios.

### 2.3.3 Responsiveness

The Responsiveness scenario contains usage models such as application launches, and file opens taken from other sub scenarios.

### 2.3.4 Overall Score

The Crossmark Overall Score is computed using the geometric mean (“Geomean”) of all 7 sub scenarios (DE, WB, SS, PE, PO, VE, RE). Productivity and Creativity each represent approximately 3/7 of the overall score each and Responsiveness is 1/7.

## 2.4 Workloads Selection

CrossMark is a cross-platform performance benchmark that models the performance of real-world applications using open source and proprietary workloads. CrossMark is based on SYSmark 25 as its calibration benchmark. CrossMark shall give results that are comparable to SYSmark 25, which is the application-based benchmark. The benchmark reports overall score and sub scores for Productivity, Creativity and Responsiveness scenarios.

For CrossMark, workloads were chosen based on the following criteria:

Key Characteristics	Description
<b>Cross-platform</b>	Support for multiple platforms. Workloads were identified that would compile natively on the following operating systems: Windows, Android (ChromeOS, Not Supported), MacOS, iOS, Chrome, Windows on ARM and Linux. Currently, CrossMark supports Windows, MacOS and iOS operating systems but may support other operating systems in future.
<b>Licensing</b>	Workloads must either have a permissive open source license (e.g. MIT, BSD or Apache) or be contributed by BAPCo members.
<b>Sensitivity Characteristics</b>	CrossMark is designed to track the sensitivity characteristics of SYSmark 25 including sensitivity to CPU frequency, CPU core count, GPU, storage device, memory, architecture, etc. The combined component scaling of all the workloads must, by definition, closely match the component scaling of SYSmark 25 at the sub scenario level.
<b>Client Usage Models</b>	The workloads are based on typical client usage models like facial recognition, compression/decompression, file I/O, document processing etc.

CrossMark workloads are based on open-source libraries as well as proprietary application code. The workload applications used in the CrossMark are listed below in the [Table 3](#). In CrossMark, source code is natively compiled for each platform (Windows, Android, macOS, iOS) using comparable compilers and flags. The compilers used for each platform are present in Workload selection [section 2.4.2](#)

#### 2.4.1 Workload Description

The list of workloads is described below:

Workload	Description
AES Encryption	The advance encryption standard (AES) is a symmetric block cipher which uses 256-bit key length to encrypt messages. The encryption is widely used to secure communication channels and to secure information. The AES workload encrypts 128kbytes of data in memory dividing in blocks based on the number of threads in the system.
Chacha20 Encryption	The Chacha20 stream cipher and poly1305 authenticator are cryptographic algorithm with aim of ensuring high-security margins while achieving high performance e.g. major sites on the internet supports this type of encryption to make it more secure and blazing fast especially in browsers like Chrome. The workload reads text file and divides into the smaller blocks to do the encryption/decryption.
Chacha20 Decryption	
Zstd compression	Zstd is a fast compression algorithm providing high compression ratios. This workload assumes compression/decompression size knowing ahead of time; the complete bound or the window size of the data to be compressed/decompressed. In this workload we compress/decompress text read using the file. Zstd streaming decompression algorithm is used when upper bound of the compressed input is unknown or large window size can result to increased memory usage. The workload takes data from the file and breaks into the smaller blocks to decompress the entire input.
Zstd decompression	
Zstd stream decompression	
Zlib compression	The lossless data compression provides in-memory compression/decompression including integrity checks of the uncompressed data. This method of compression/decompression technique is designed to be compact and fast for use in memory and on communication channels. The workloads using deflate/inflate take input from a file and breaks into smaller chunks to do the compression/decompression and writes into the output file.
Zlib decompression	
Search	Search refers to the natural language string matching such as 'find' in word processing. This algorithm matches a set of string fragments on a character stream in memory. Each pattern matching is done via parallel processing to know the count of that pattern on given set of character stream.
File read	File read/write allows random access to file's contents by enabling to open the files, seek to a

	particular location and read/write to that file location. This helps to read/write to any part of the file directly. In this workload input from a file in which random read/write is performed each of small block sizes.
External Sorting	This workload is a class of sorting algorithm that can handle massive amount of data and used when data being sorted cannot fit into the main memory of a computing device (usually RAM) and instead must reside in the slower external memory (usually a hard drive). This workload executes by splitting files unsorted files into many thousands of files by doing the quicksort for each split. In the merge phase, sorted subfiles are combined into a single larger file.
SQLite	SQLite is a relational database management system contained in a C library. It is arguably the most widely deployed database engines used today in browsers, operating systems, embedded systems (mobile phones), among others. SQLite workload executes thousands recursive SQL queries to create random blobs sizes to be inserted into the database.
Rendering Frames	This workload renders thousands of frames processing the buffers in parallel doing the computation.
Object Detection	Object detection is one of the most popular computer vision algorithms out there. Its goal is to find all the objects of interest on the video and output their bounding boxes. It is applied to really a wide range of objects – all the way from cars to bacteria. When we look at images or videos, we can easily locate and identify the objects of our interest within moments. You Only Look Once or more popularly known as YOLO is one of the fastest real-time object detection algorithms used in this workload. This workload is based on inference as it starts with the pre-trained model for images, videos and does multiple object detection of 720p video stream.

Image Colorization	Colorization is the process of taking an input grayscale (black and white) image/video stream and then producing a colorized output image/video that represents the semantic colors and tones of the input (for e.g., an ocean on a clear sunny day must be plausibly “blue” – it cannot be colored “hot pink” by the model.) The novel approach used in this workload relies on deep learning utilizing neural network based on Caffe models capable of colorizing black and white images.
Video Colorization	
HDR	The workload takes five standard dynamic range images and produces high dynamic range image. There are different ways to obtain HDR images but the most common one is to use photographs of the scene taken with different exposure values.
Face recognition	Face recognition is based on the geometric features of the face based on Eigenfaces method. A facial image is a point from a high-dimensional image space and a lower-dimensional representation is found where classification becomes easy. The workload take ORL database of faces contains ten different images of distinct subjects. For some subjects, the images were taken at different times, varying the lighting, facial expressions (open/closed eyes, smiling/not smiling) and facial details. The Eigenfaces model is trained with the images. The test image is provided to get the confidence of prediction.
Black Scholes (multi-threaded)	The workload is based on generating random number based on a probability distribution. The random number then uses the additional inputs of volatility and time to expiration to generate a stock price. It uses pseudo random number generator based on a matrix linear recurrence over a finite binary field and provides fast generation. The generated stock price at the time of expiration is then used to calculate the value of the option. The model then calculates results over and over, each time using a different set of random values from the probability functions. Depending upon the model, the number of uncertainties and the probability distributions used, it uses tens of thousands of recalculations before it completes. It typically relies on the average of all the calculated results as an options price.
Black Scholes (single-threaded)	
Video Tracking	The video tracking the goal is to find the object in the current frame given we have tracked the object successfully in all previous frames. This tracker tracks the object in both forward and backward directions in time for video.

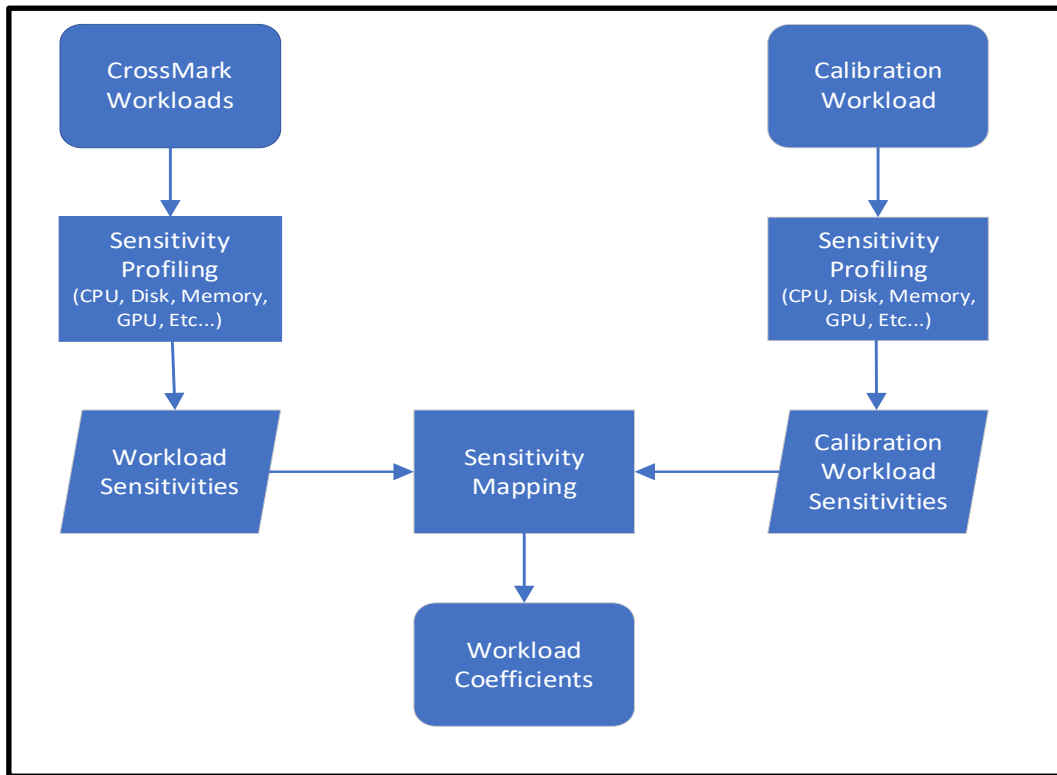
### Workload Compilation

CrossMark uses Clang compiler based on open source compiler for the C family of programming languages for natively compiling workloads on different operating systems. Clang builds on the LLVM optimizer and code generator. CrossMark uses the -O2 optimization flag during compilation. Here is the version of Clang compiler used for each operating system:

- Windows – Clang 10.0.0
- macOS – Apple Clang 12.0.0
- iOS/iPadOS – Apple Clang 12.0.0
- Android – NDK r21 Toolchain

## 2.5 Workload Coefficient Mapping

The goal of workload coefficient mapping is to determine a coefficient for each CrossMark workload. BAPCo uses a set of 22 workloads with various sensitivities to represent the performance of each of the seven sub-scenarios ([see section 2.3](#)) in SYSmark 25. The coefficient mapping is done for each of the sub-scenarios (calibration workloads) to generate a set of workload coefficients. The set of workloads with its coefficients represents the performance of the calibration workload.

Here is a description of the mapping process shown in Figure 1:

1. Each of the CrossMark workloads is profiled to determine its sensitivity to various system components using a Windows 10 system. These components include CPU, Disk storage, Memory and GPU, sensitivity in addition to other secondary sensitivities. (While the exact same code base is used on all platforms, individual sensitivities may vary on other platforms.)
2. The targeted SYSmark 25 sub-scenarios are also profiled to determine the sensitivity to the same system components.
3. The matrix of sensitivities for both the CrossMark workloads and the target SYSmark 25 sub-scenario are put through a linear algebra solver which finds the best possible set of coefficients for each of the CrossMark workloads to represent the profiled sensitivities within the SYSmark 25 sub-scenario.

4. These workload coefficients are configured into CrossMark and are used to scale the workload performance on the system under test to generate sub scenario scores and ultimately the overall CrossMark score.



## 2.6 Scoring Methodology

A complete CrossMark run will display the following performance ratings: CrossMark Overall Rating, a Productivity Rating, a Creativity Rating, and a Responsiveness Rating.

### 2.6.1 Workload Rating

Each workload is executed exactly once per benchmark iteration, and some workloads may appear in multiple sub-scenarios. This saves runtime and gives more consistent results. The rating for each workload is the calibration runtime divided by the measured runtime on the test system and multiplied by 1000. Workload ratings are not displayed in the benchmark output.

### 2.6.2 Sub Scenario Rating

The sub scenario rating is the sum of each of the workload ratings multiplied by the workload coefficients for the corresponding sub scenario, [see section 2.5](#). Sub scenario ratings are not displayed in the benchmark output.

### 2.6.3 Productivity Rating

The Productivity Rating is calculated by taking the geometric mean of all the Document Editing (DE), Spreadsheets (SS), and Web Browsing (WB) sub scenario ratings (prior to rounding). The result is then rounded to the nearest integer.

### 2.6.4 Creativity Rating

The Creativity Rating is calculated by taking the geometric mean of all the Photo Editing (PE), Photo Organization (PO), and Video Editing (WB) sub scenario ratings (prior to rounding). The result is then rounded to the nearest integer.

### 2.6.5 Responsiveness Rating

The Responsiveness rating is simply the Responsiveness sub scenario rating taken as is.

### 2.6.6 Overall Rating

The CrossMark Overall Rating is calculated by taking the geometric mean of all seven of the sub scenario ratings (prior to rounding). The result is then rounded to the nearest integer. The goal of the CrossMark Overall Rating is to be within  $\pm 5\%$  of the SYSmark 25 Overall Rating when running on an identical system with an identical configuration.

## 2.7 Calibration System

The calibration system is chosen in milestone 16 as a reference point for all other CrossMark results. BAPCo chose the configuration below for its wide availability and its representation of a typical mainstream PC at the time of release of CrossMark. This calibration system matches with SYSmark 25 calibration system as CrossMark shall give results that are comparable to SYSmark 25, which is the application-based benchmark from BAPCo.

CrossMark is calibrated in such a way that a PC with performance equivalent to this calibration system for a given workload will have a performance rating of 1000. A system twice as fast as the calibration system on a given workload (or, equivalently, that responds in half the time on average) will have a performance rating of 2000. This is true for both overall ratings and scenario ratings.

The calibration system for CrossMark has the following configuration:

- Lenovo® ThinkCentre™ M720q
- Processor: Intel® Core™ i5-8500T @ 2.10 GHz
- Operating System: Microsoft Windows 10 Pro x64 20H1 (10.0.0.1863.418)
- RAM: 1x8 GB DDR4 single channel
- Graphics: Intel® HD Graphics 630
- Resolution: 1920x1080
- Audio: Integrated High Definition Audio
- Storage: 256GB NVMe SSD
- Networking: Integrated Gigabit Ethernet

A fresh operating system installation is performed on the system (not an OEM factory optimized image).

The calibration sum for each sub scenario is obtained according to the following process:

- Run CrossMark on the calibration system (conditioning run enabled, 3 iterations)
- For each sub scenario we:
  - Identify the median iteration by finding the iteration with the median sub scenario rating score.
  - The calibration sum for the sub scenario is the response time total from that sub scenario in the median iteration.

The CrossMark calibration system is the basis for determining the reference scores for the benchmark only and is not intended as an example of minimum system requirement. Refer [Appendix B](#) for information on minimum system requirements.

## 2.8 Cross Platform Comparisons

One of the main goals of CrossMark is to provide a measure of system performance across multiple platforms. These are the processes BAPCo followed:

The workload contributions to the overall rating are determined during Workload Coefficient Mapping refer [section 2.5](#). The calibration system score is determined during benchmark calibration refer [section 2.7](#). These processes are done one time and used for all systems on all platforms. Here are few more considerations:

- The same source code is used on all platforms. The majority of the code that is executed in this benchmark is code that is compiled directly from the C/C++ code supplied within the benchmark. Avoiding unnecessary system libraries makes the workloads as comparable as possible.
- Workloads are compiled natively on each platform (x86\_64, ARM64) using comparable compilers (see [section 2.4.2](#).) and flags. BAPCo may add new architectures in future to support other platforms.

### 3 Workload Characteristics

This section provides data illustrating the performance characteristics of CrossMark version 1.0.0.73.

#### 3.1 Sensitivity Analysis

The series of charts below shows the sensitivity of CrossMark to different system characteristics, including the amount of CPU frequency, number of CPU cores, storage, graphics adapter, system memory, and display resolution.

Within each study only one system component (e.g. memory) is varied. All the other system components are held constant. To best illustrate the sensitivity, one configuration is chosen as a baseline and the ratings for the other configurations are shown as the percentage difference relative to the baseline.

Due to system implementation differences, these figures are only accurate for the configuration description listed below in each sub-section. These sensitivities will vary from one configuration to the next.

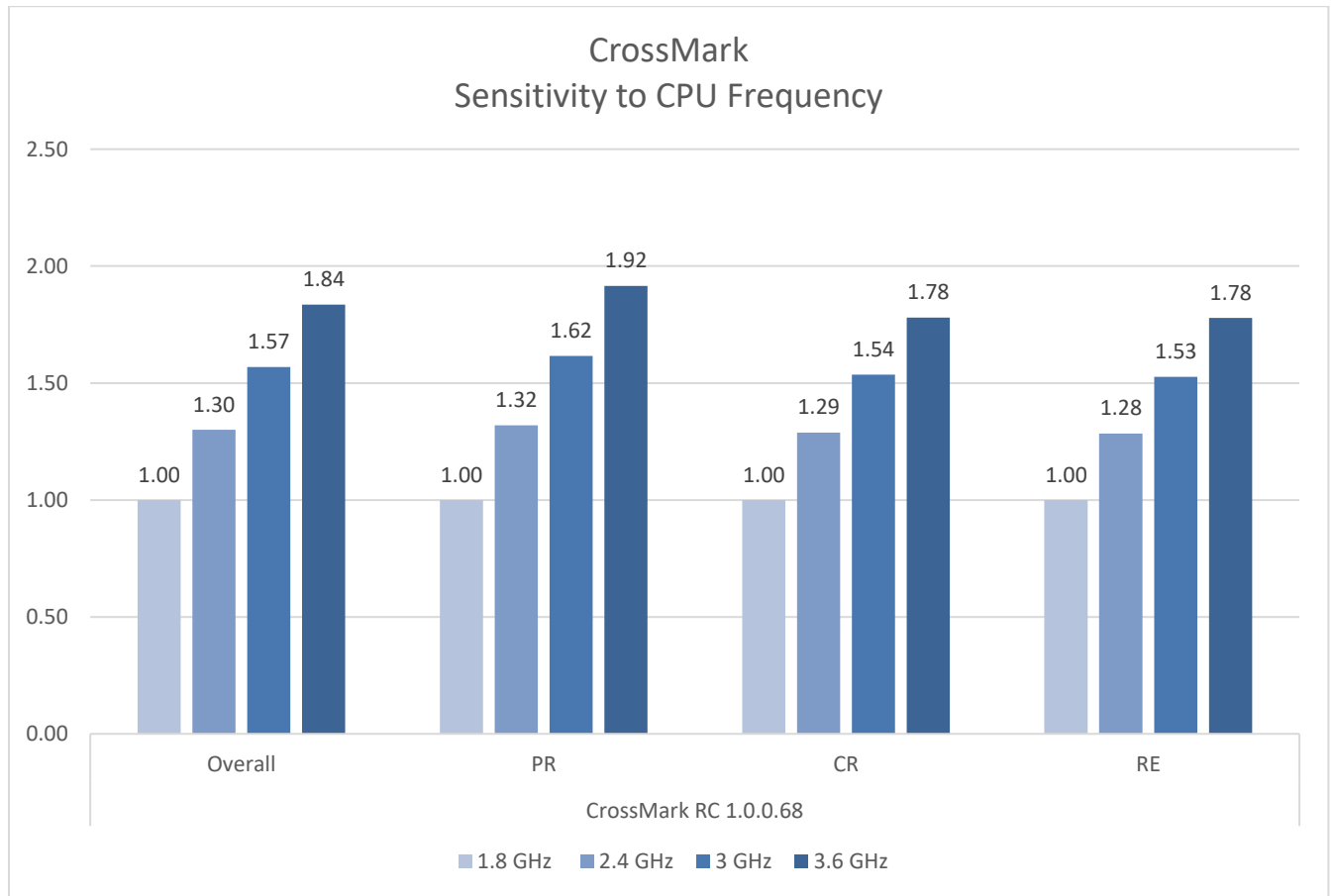

Note: For these tests, Intel Turbo Boost Technology and Intel Hyper-Threading Technology have been disabled to better highlight the specific component being tested in each sensitivity study.

### 3.1.1 Sensitivity to CPU Frequency

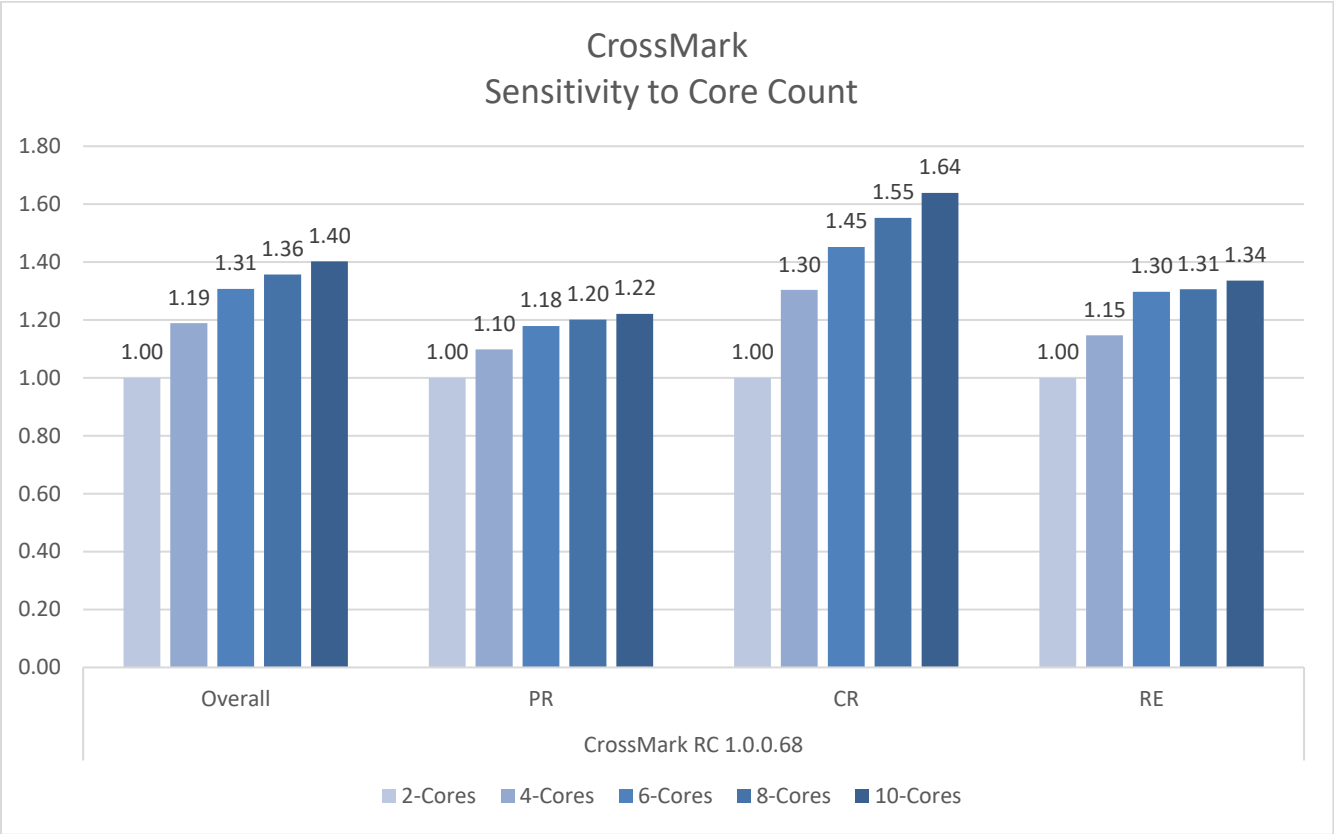
The CPU frequency of a system is changed from 1.8 GHz to 3.6 GHz in steps of 600 MHz

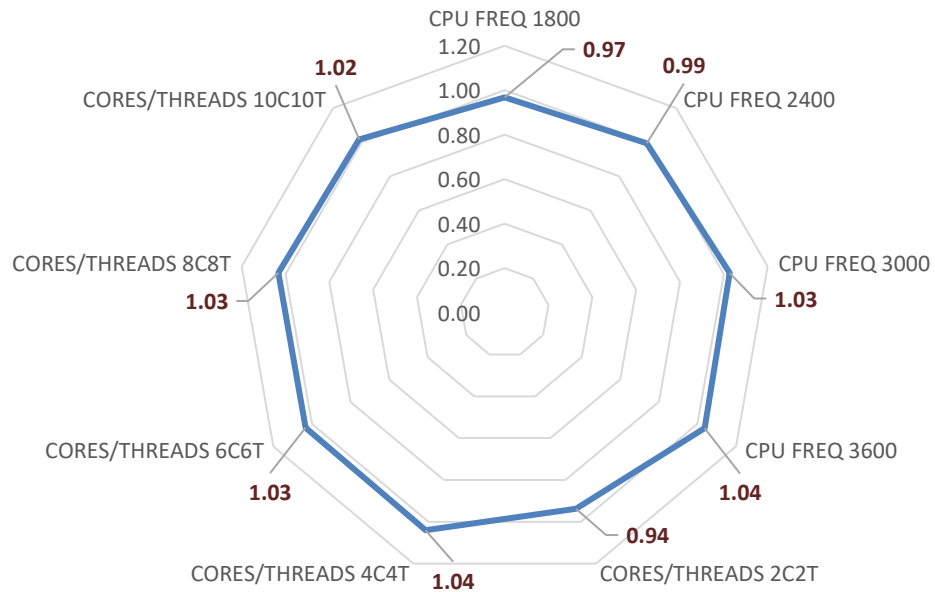
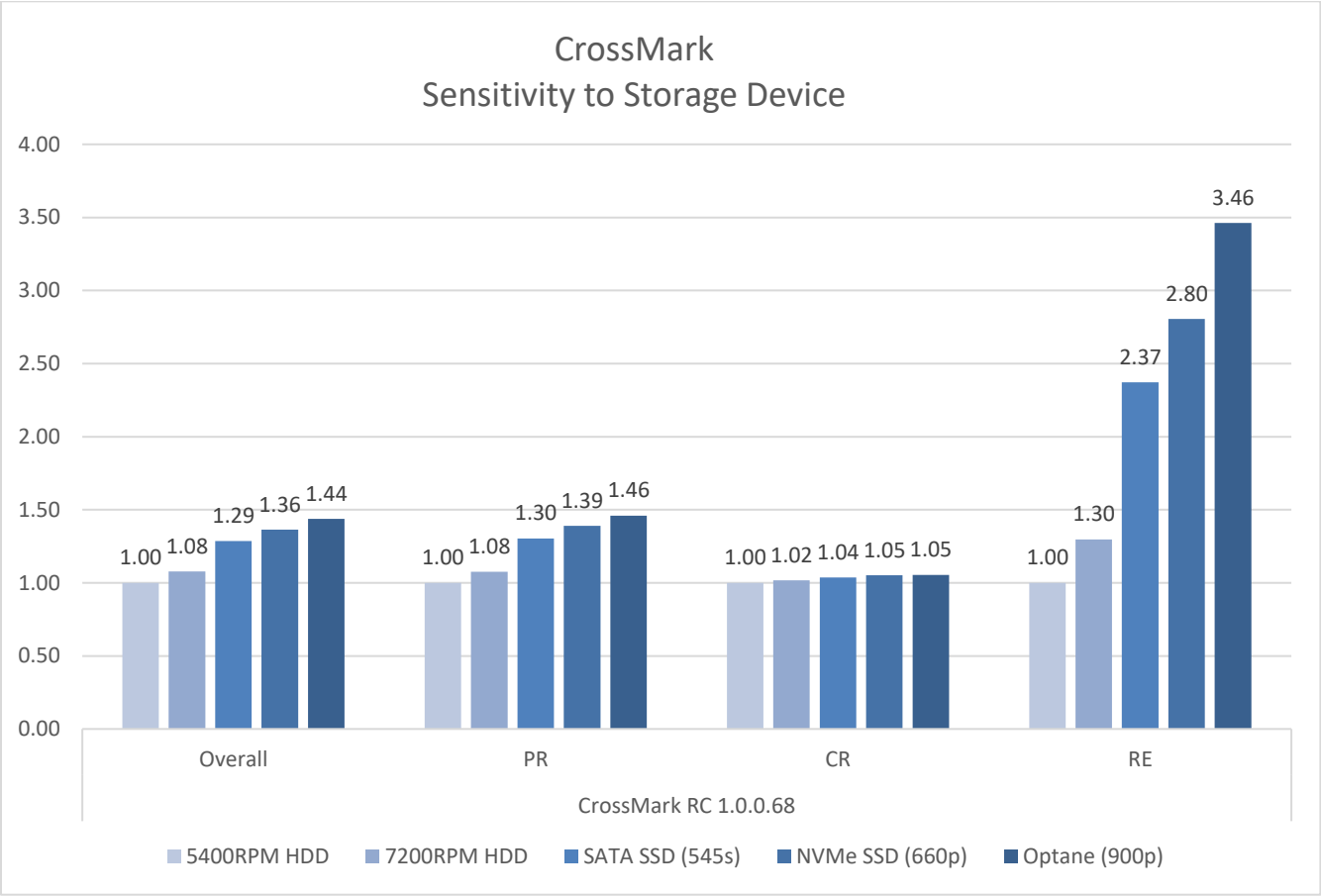


Figure 4 SYSmark25 vs CrossMark CPU Core & Frequency Sensitivity Comparison

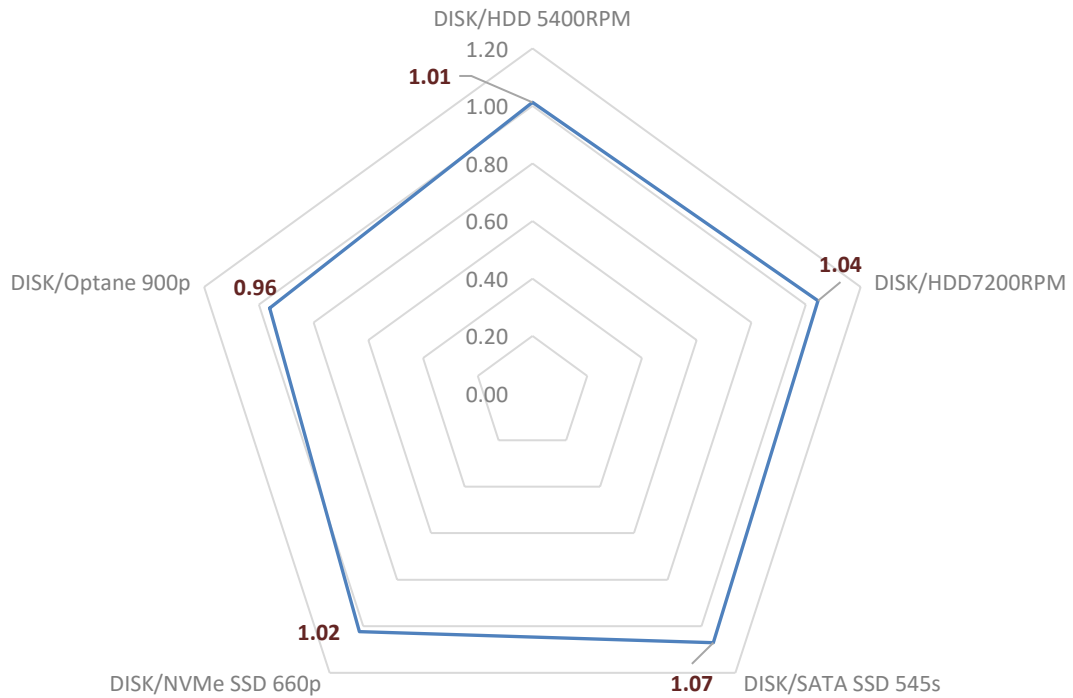

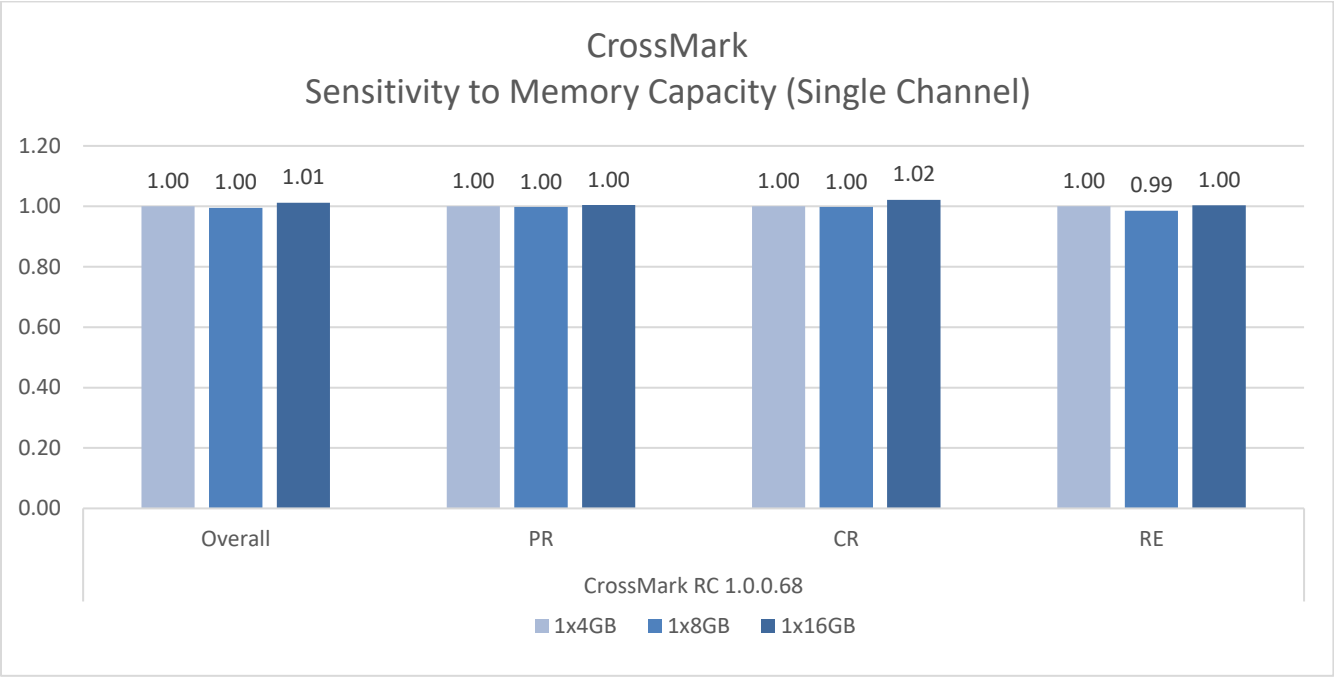
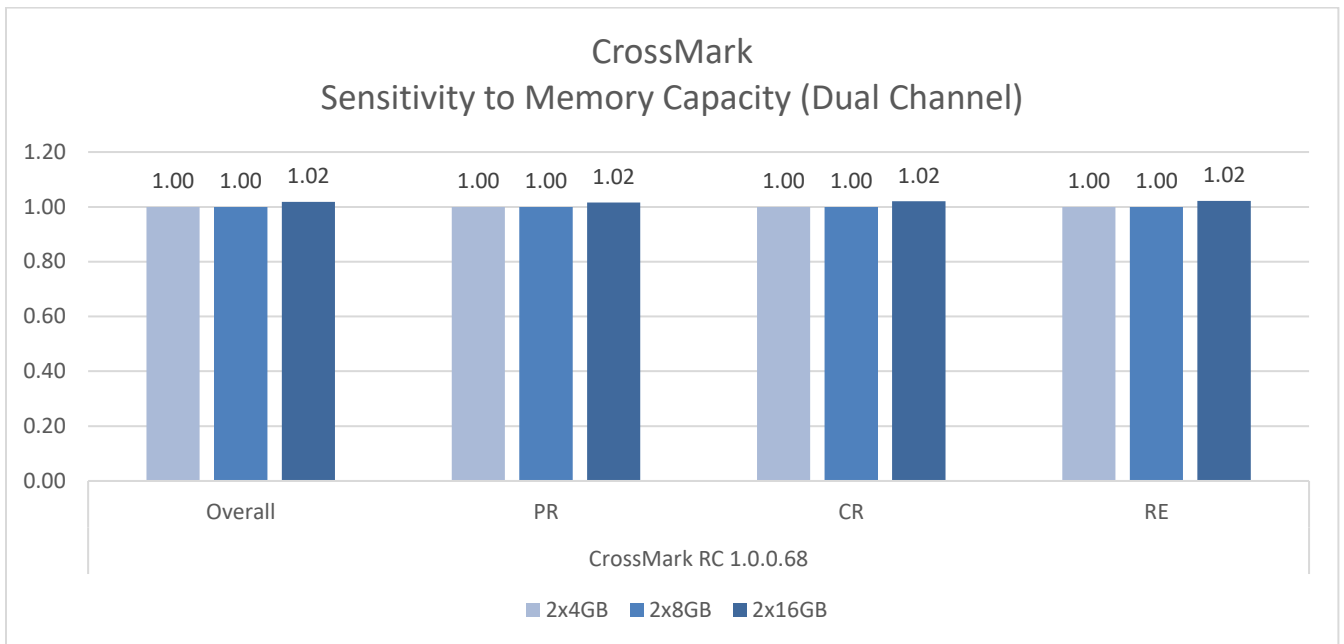
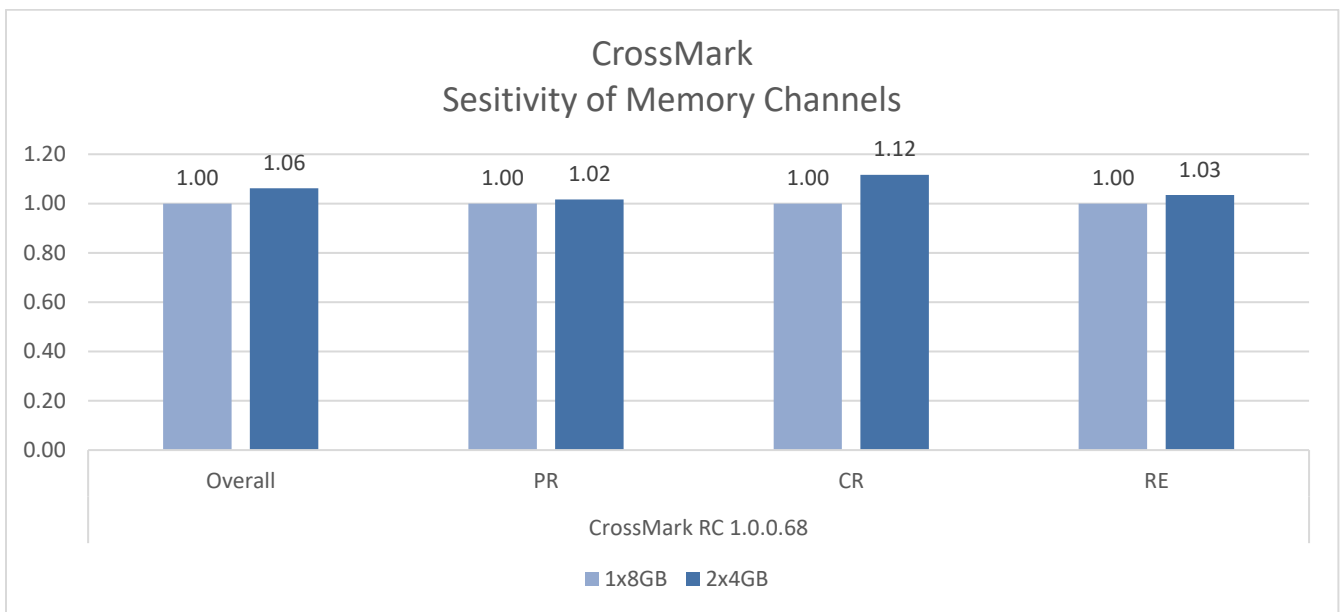


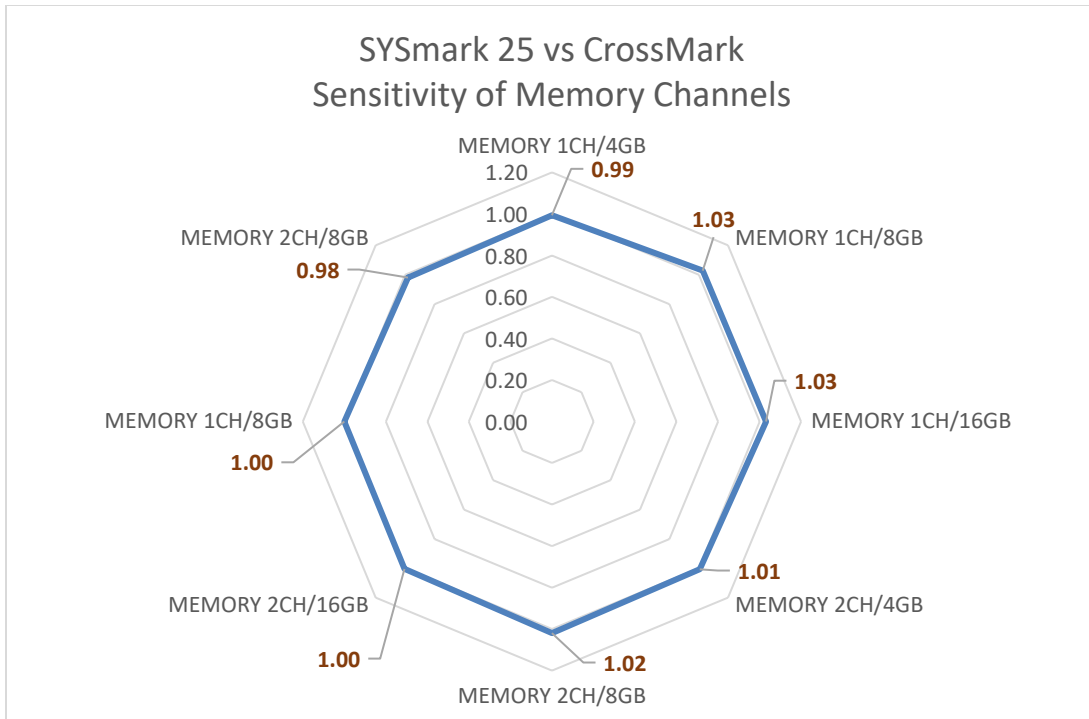
Figure 7 System Memory Sensitivity (Single Channel)



**Figure 8 System Memory Sensitivity (Dual Channel)**



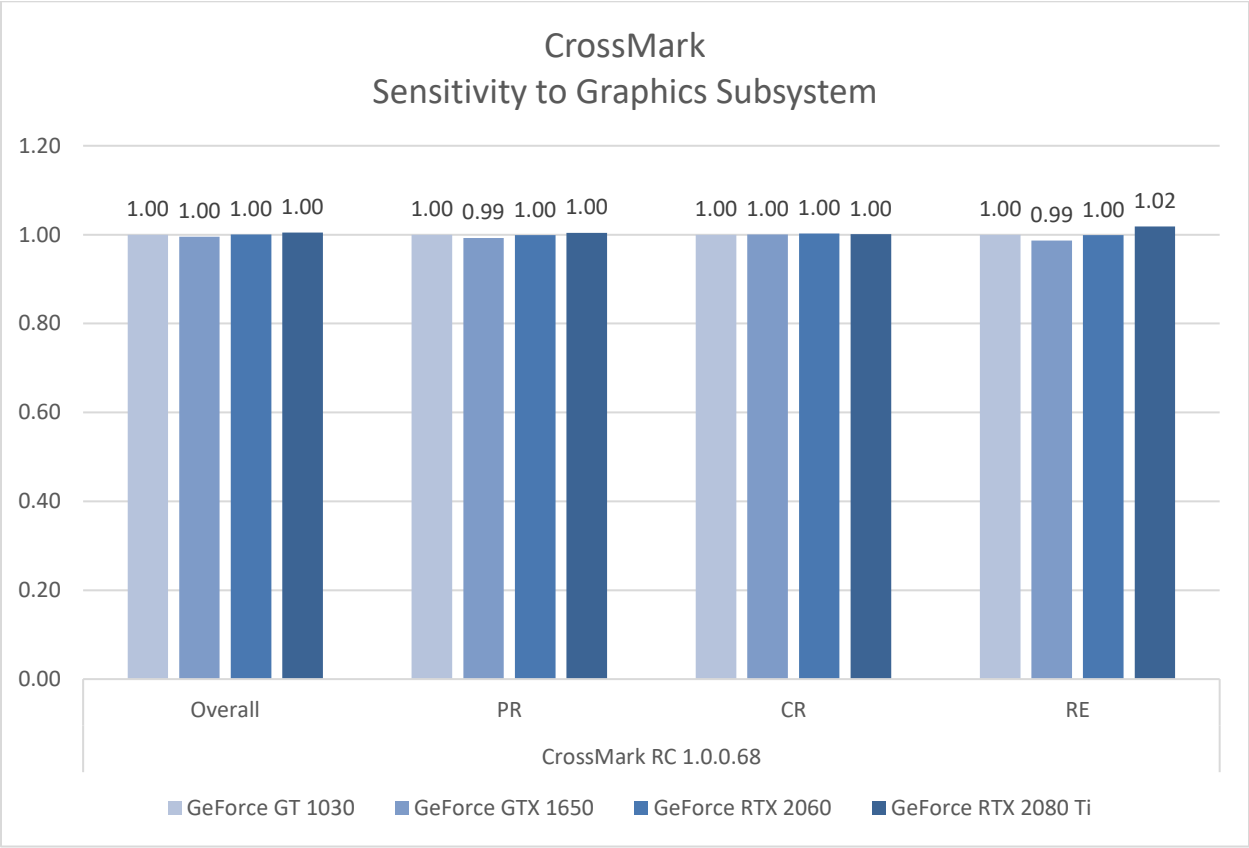
**Figure 9 System Memory Channel Sensitivity (Single vs. Dual Channel)**

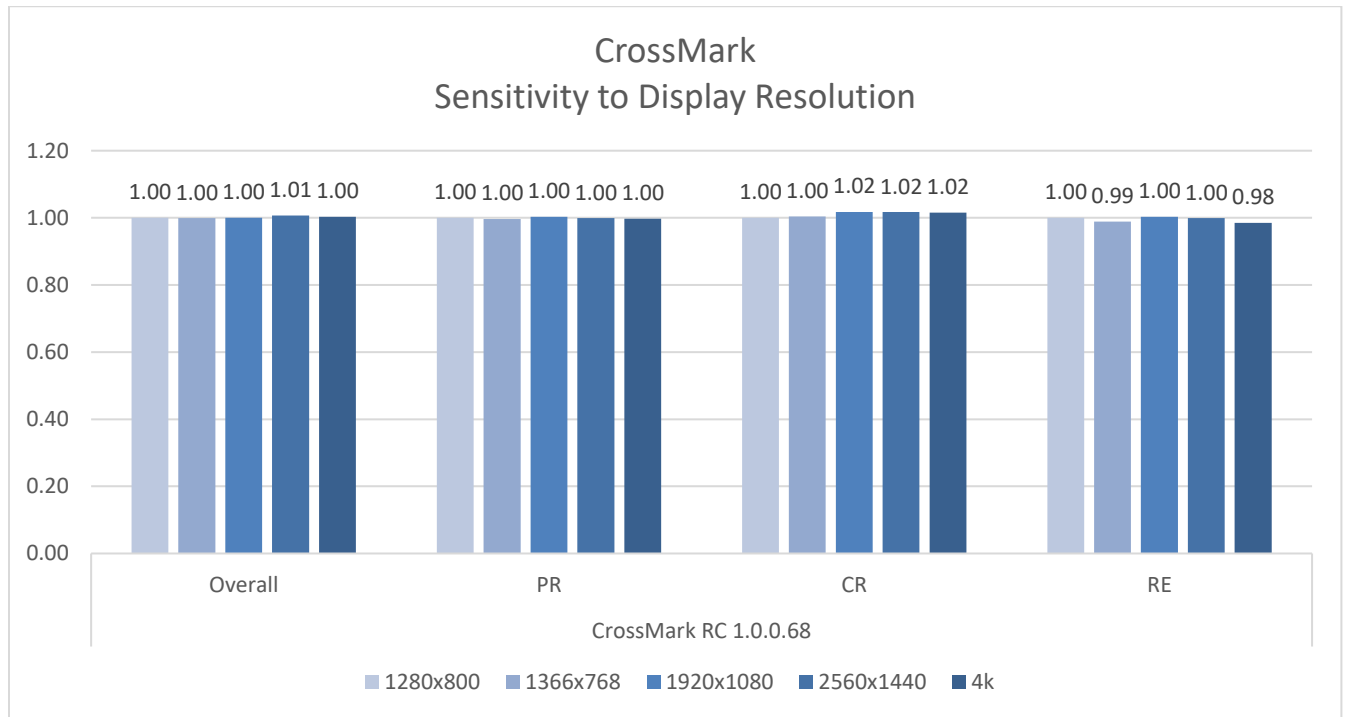

**Figure 11 Graphics Subsystem Sensitivity**

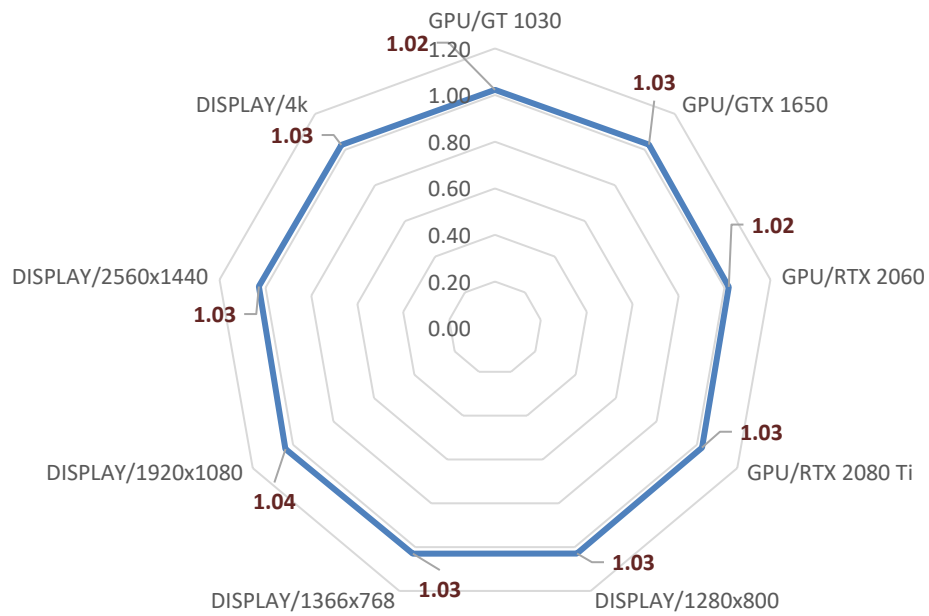

### 3.2 System Configuration Tool Items List

The system configuration settings are recommended to be made before running CrossMark to obtain repeatable scores and minimize the occurrence of errors on Windows and macOS platforms. When testing CrossMark on notebook systems/phones/tablets, please be sure the system or device is plugged into AC power for best results. This section gives an overview of the required settings followed by the steps to make the required modification in system settings.

Note: Some of these settings is via registry editor. Here is the link below to back up your current setting in the registry editor. This shall help to restore the original setting back by importing them after test is run for system to return to original state

#### 3.2.1 Required settings

Make configuration changes that are required for the benchmark to run to match the results of SYSmark 25.

##### 3.2.1.1 [Disable User Account Control \(UAC\)](#)

Disables User Account Control to prevent Administrator elevation prompts from appearing during benchmark runs. The system must be rebooted to apply this change.

##### 3.2.1.2 [Disable Low Battery Actions](#)

Prevents the system from shutting down or from posting a warning when the battery reaches the low level.

##### 3.2.1.3 [Disable Windows Update](#)

Disables the Windows update service.

##### 3.2.1.4 [Disable WinSAT service](#)

Disables the WinSAT service

##### 3.2.1.5 [Disable Windows Search](#)

Disables Windows search service.

##### 3.2.1.6 [Disable Diagnostic policy service](#)

Disables Diagnostic policy service.

##### 3.2.1.7 [Disable SysMain service](#)

Disables SysMain service.

##### 3.2.1.8 [Create BAPCo Power Scheme](#)

Creates a new power scheme named "BAPCo CrossMark" based on the system's currently active power scheme. If applied, all subsequent power profile configuration changes will be applied to



the newly created power scheme. If this option is not enabled, all power profile configuration changes will be applied to the currently active power scheme.

3.2.1.9 [Set Power Plan Type to "High Performance"](#)

Sets the "Power Plan Type" option (sometimes referred to as "Power Plan Personality") of the active power scheme to "High Performance". This setting tags the active power plan with an overall personality that favors performance over energy savings. Drivers and applications may query this setting to determine their respective performance vs energy savings behavior. This option may be used whether or not the "Create BAPCo Power Scheme" option is checked. If "Create BAPCo Power Scheme" is not enabled, "Set Power Plan Type" will be applied to the currently active power scheme.

3.2.1.10 [Set CPU High Performance](#)

Sets the minimum and maximum value for CPU performance state to 100% to prevent CPU throttling on both AC and DC power.

3.2.1.11 [Disable Windows Defender](#)

Sets Windows Defender to disabled. If Tamper Protection is turned on, this setting can't be altered.

3.2.1.12 [Disable Tamper protection](#)

Disables tamper protection to allow the Windows defender to be disabled.

3.2.1.13 [Disable Hard Disk Timeout](#)

Prevents the hard disk from going to sleep

3.2.1.14 [Ignore Laptop Lid Close](#)




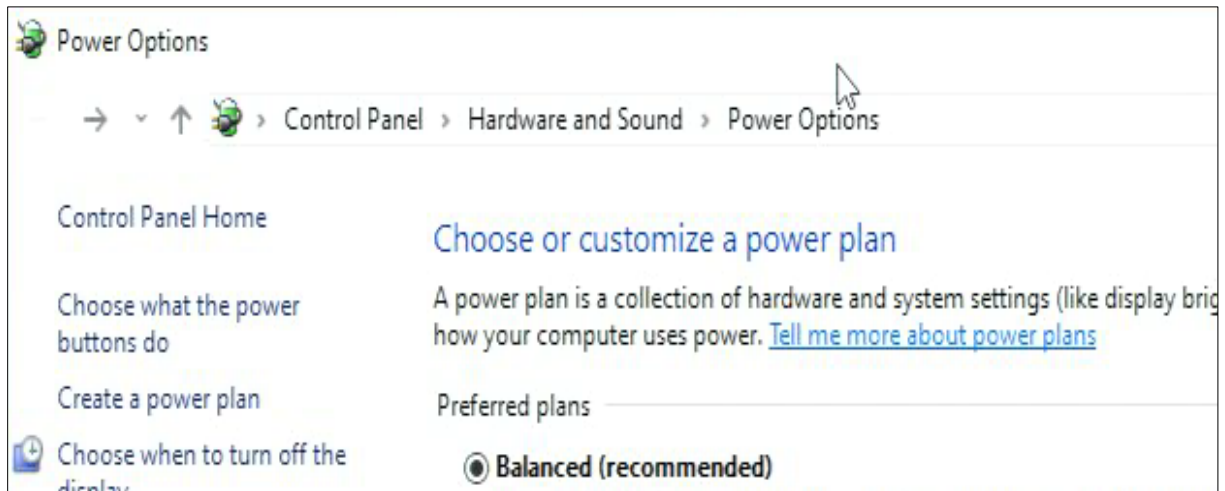

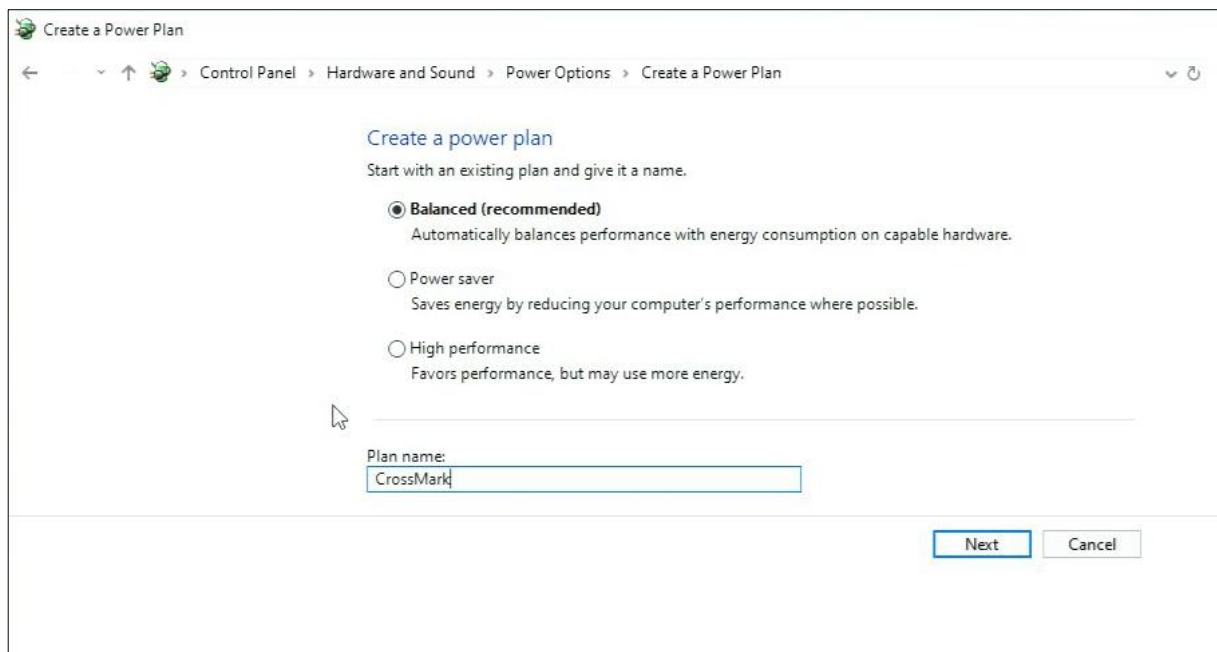

**Figure 14 Power options window**

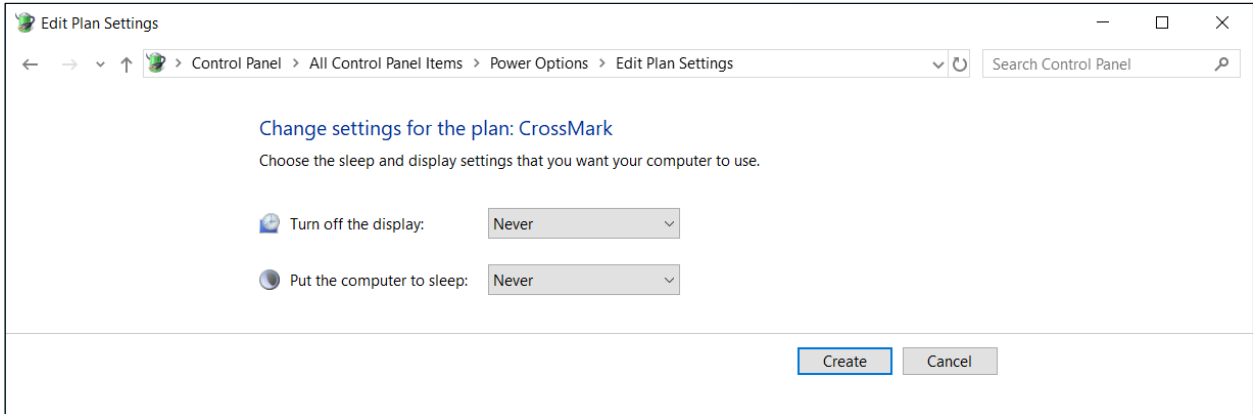

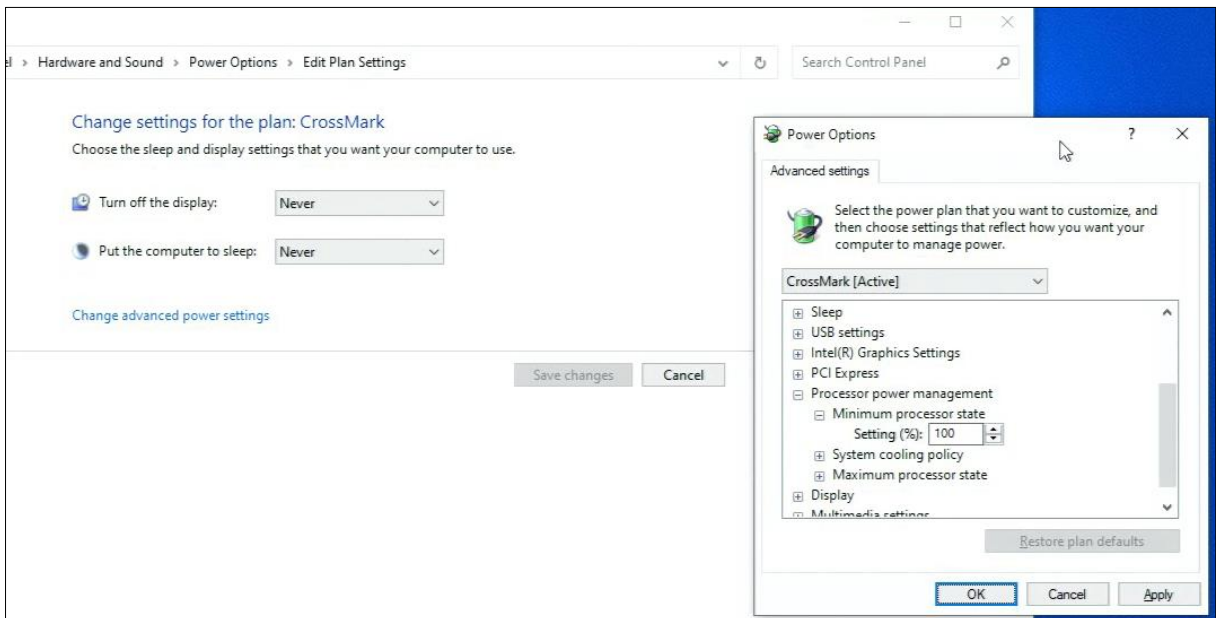

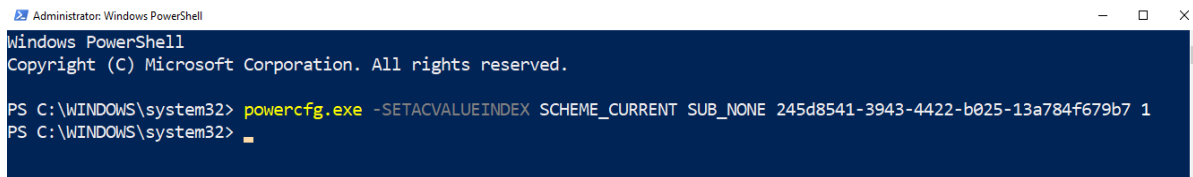
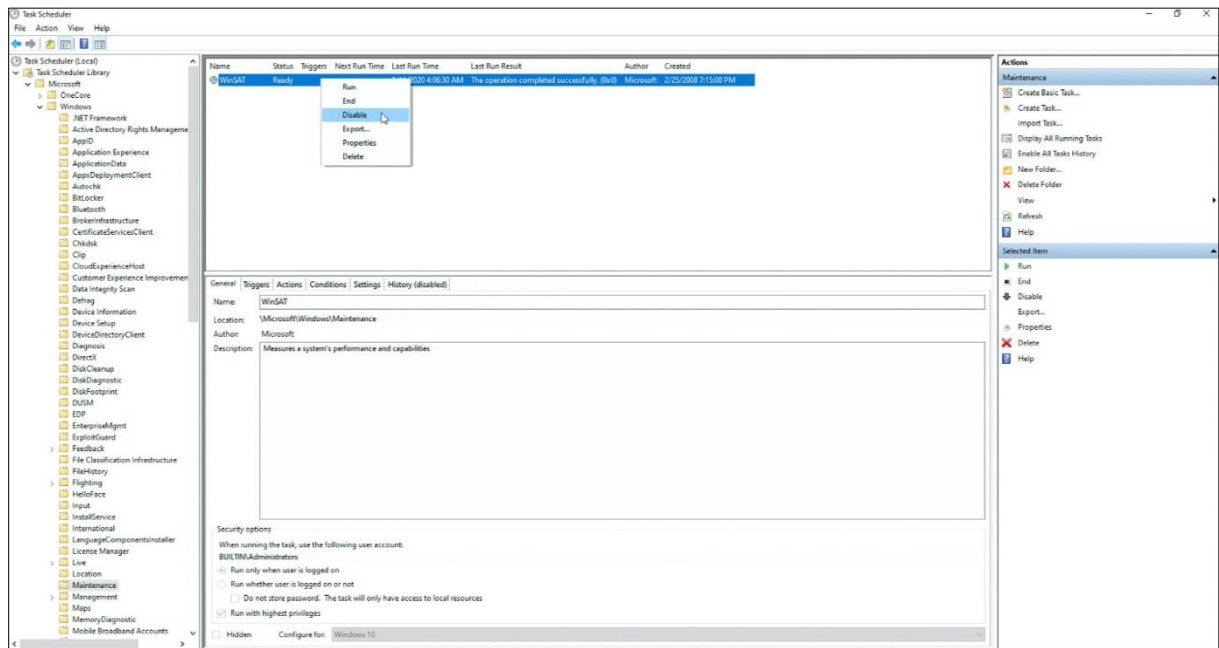


Figure 18: Power plan personality settings

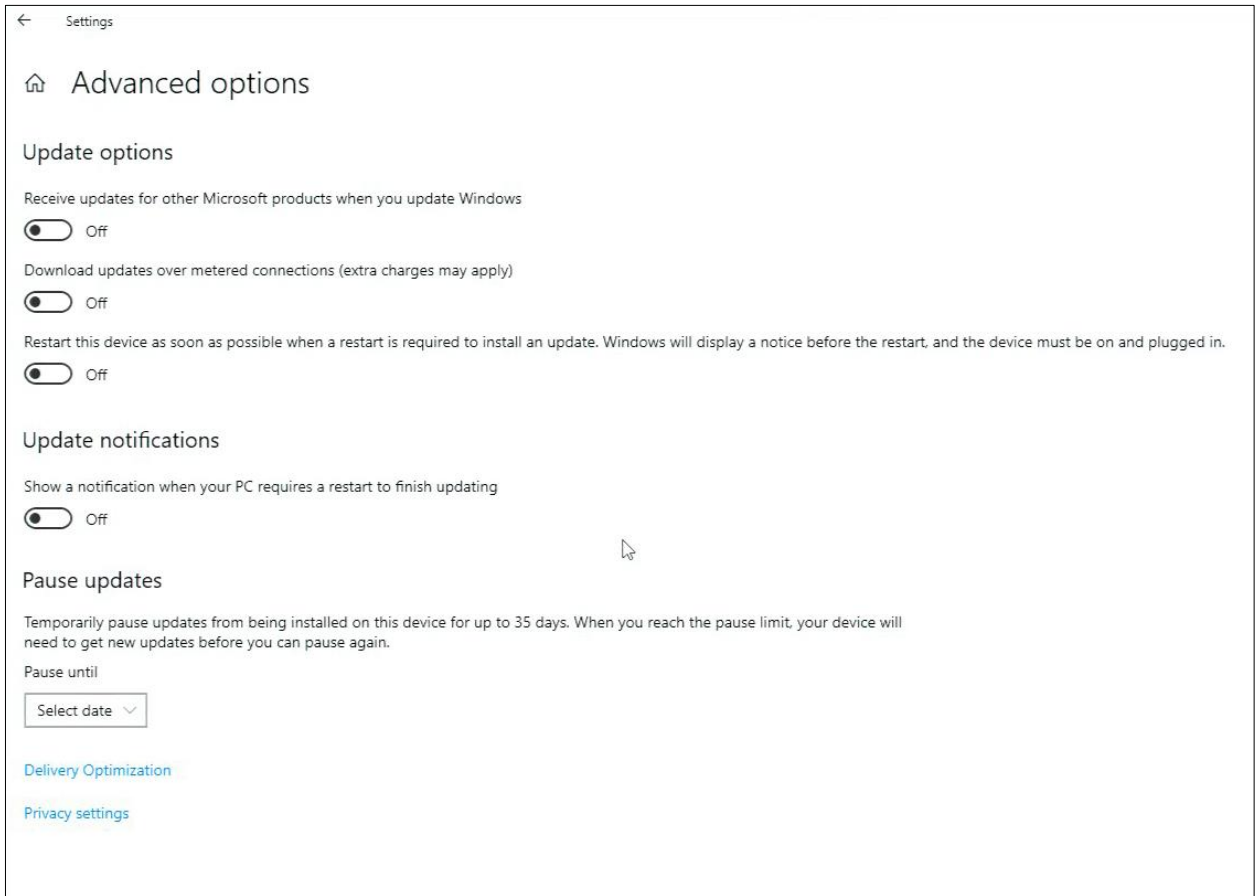


**Figure 19** Task Scheduler to disable WinSAT

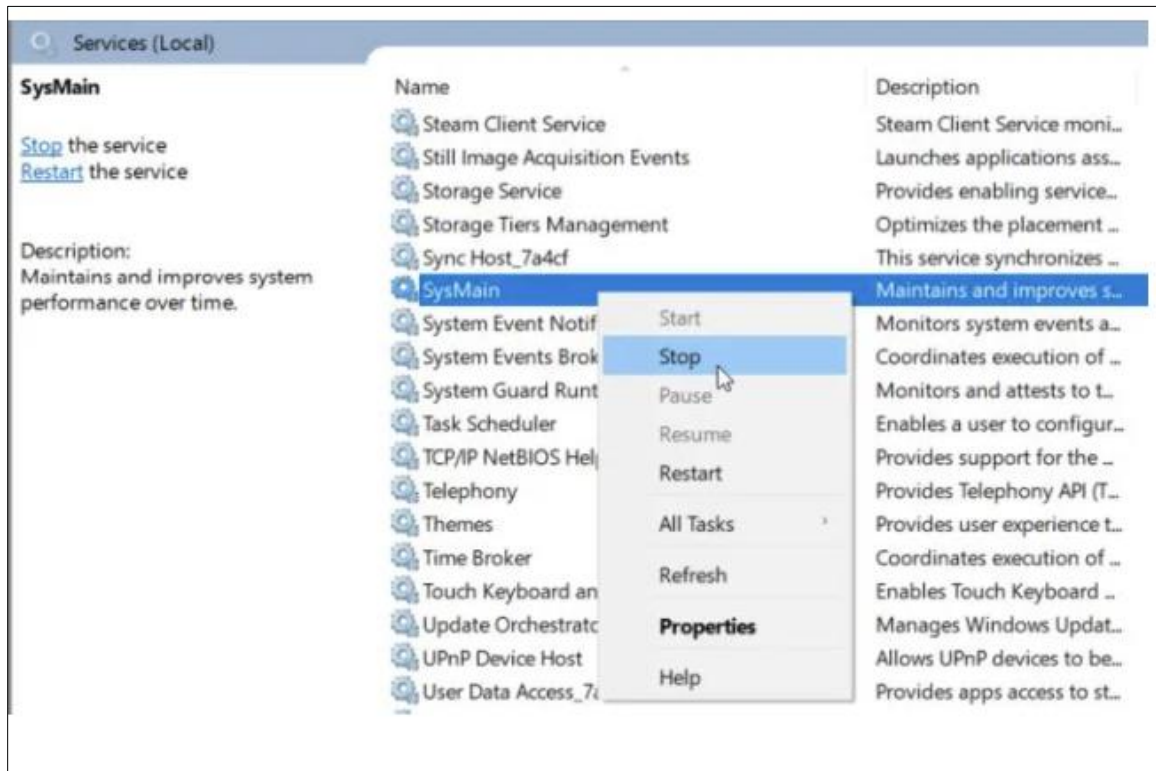

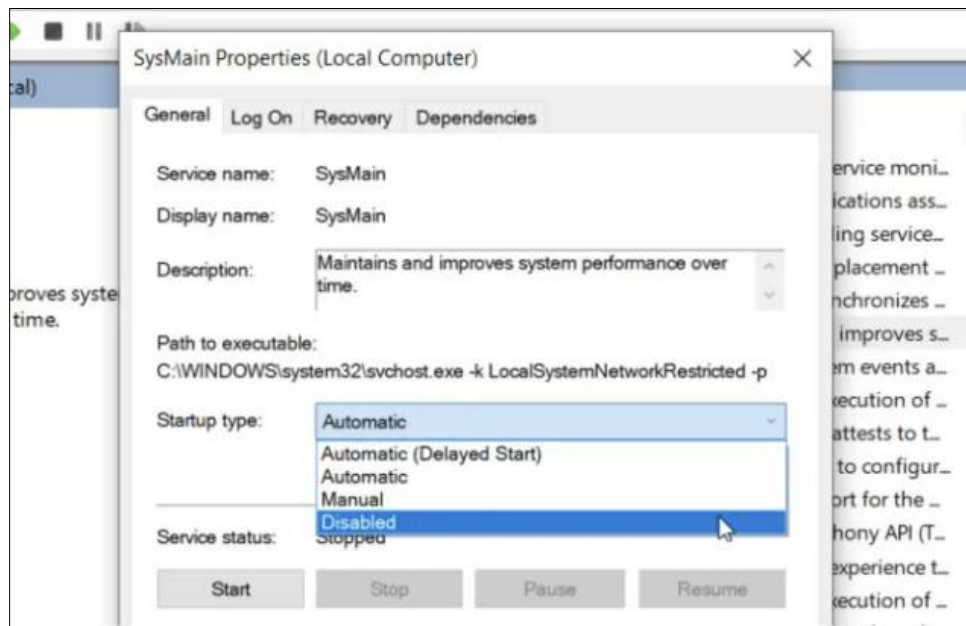

**Figure 21 Services option to stop SysMain service**



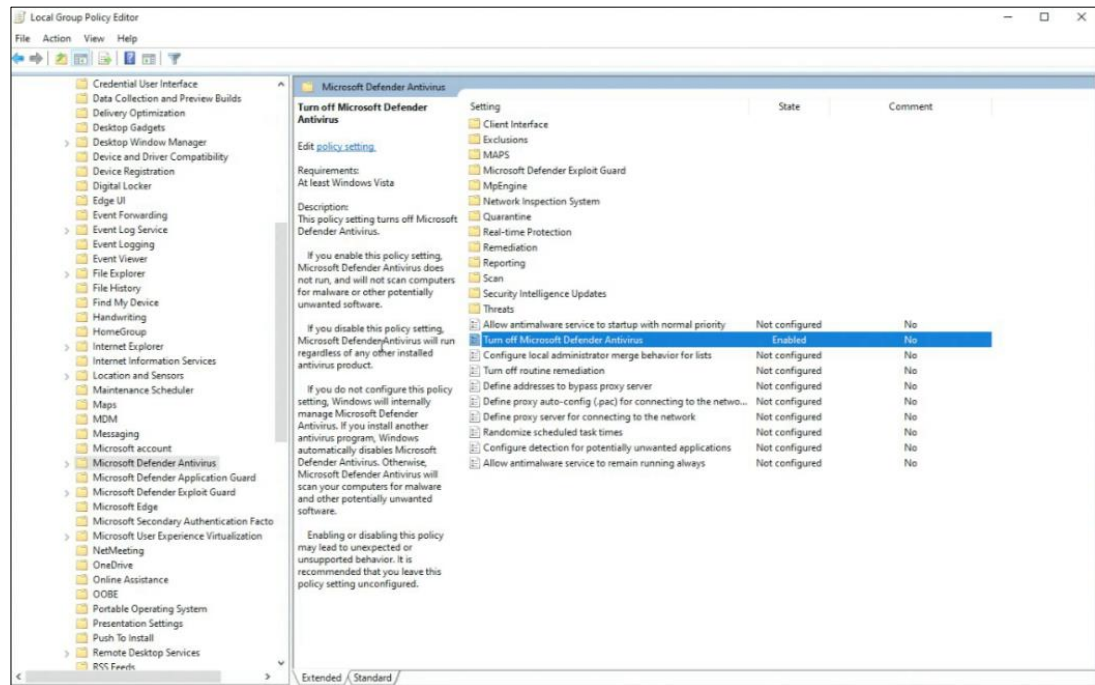
**Figure 22 Services option to disable SysMain service**

**Figure 23** Local Group Policy Editor options to disable Windows defender






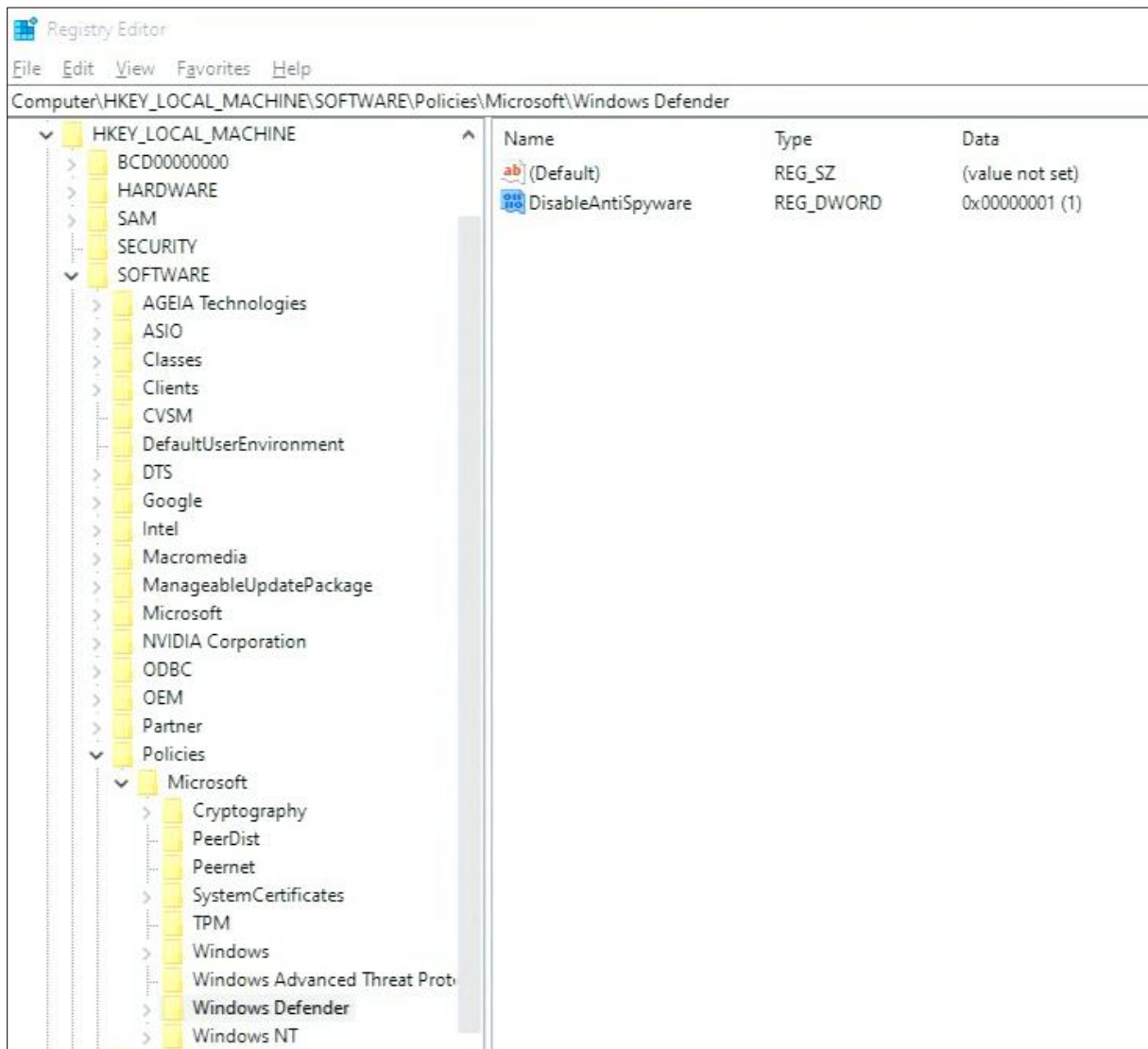



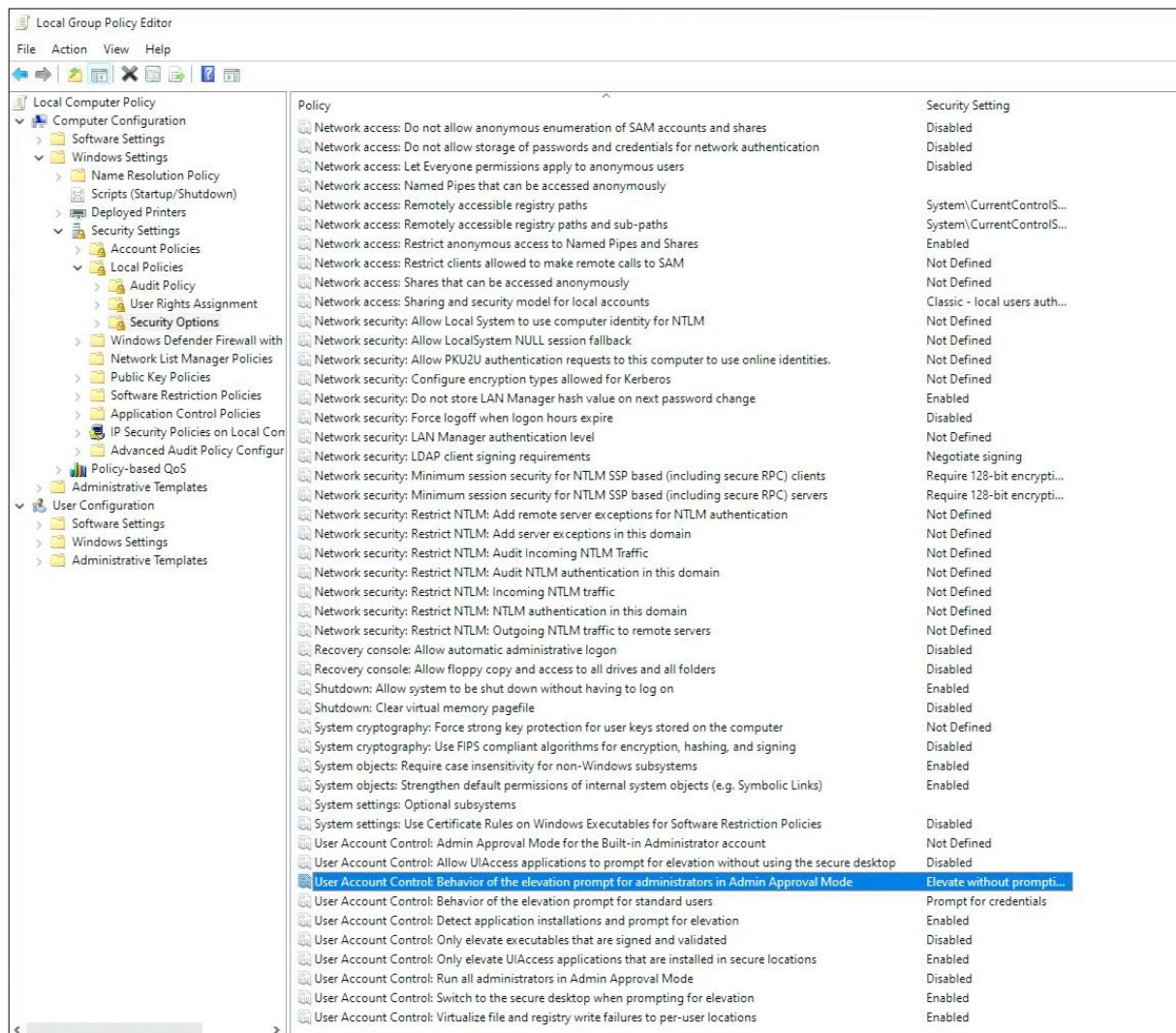


**Figure 24** Disable Windows defender using Registry editor

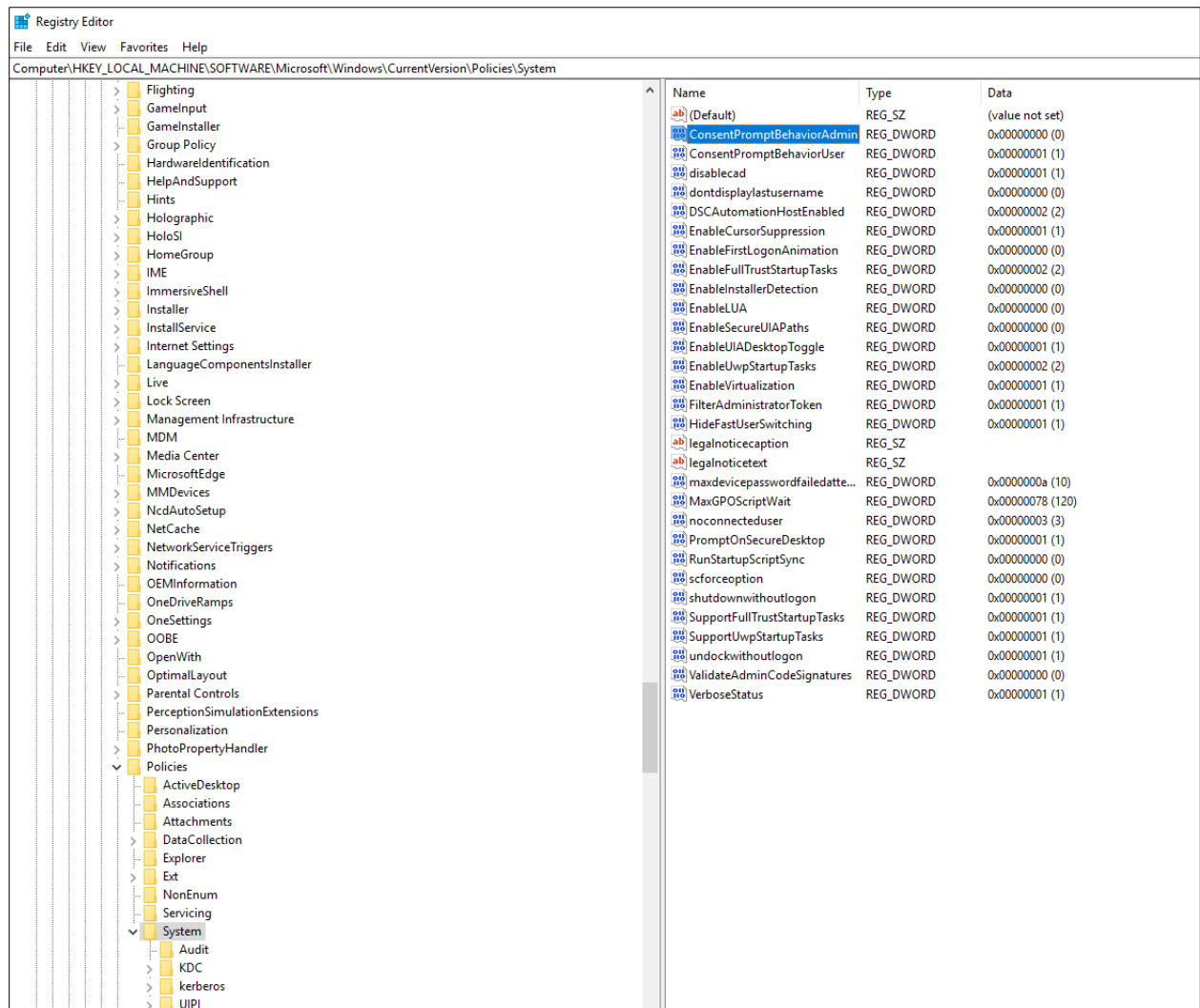

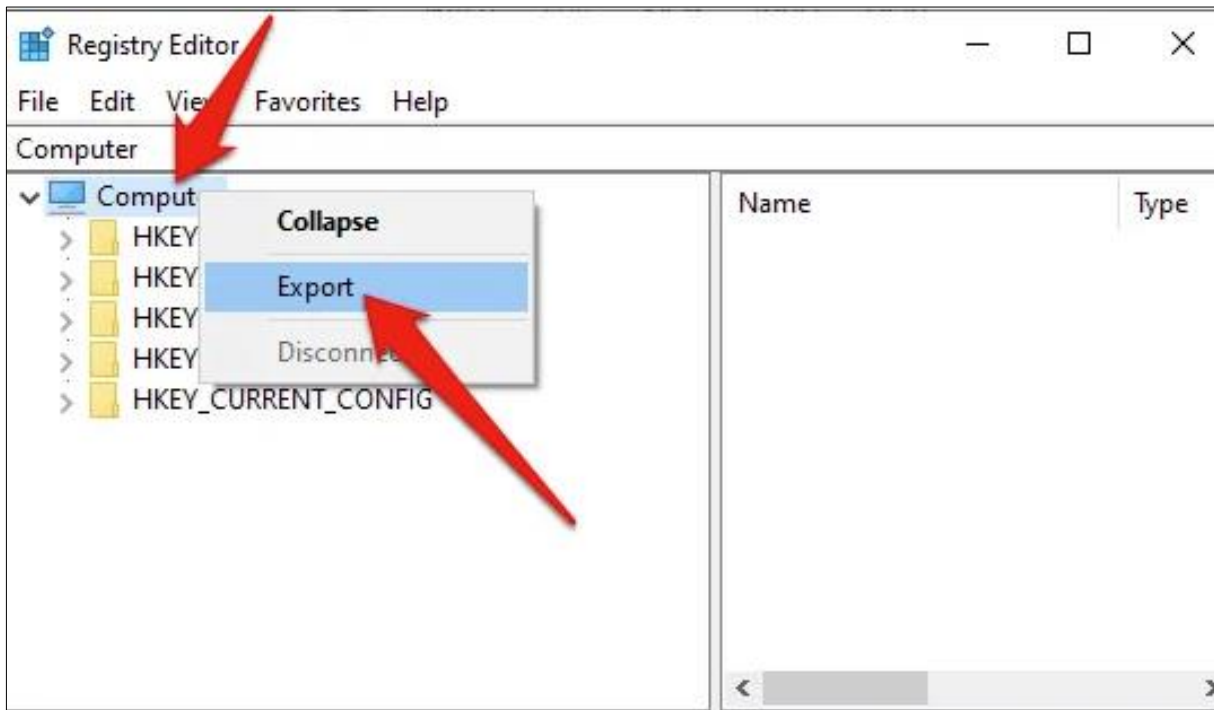

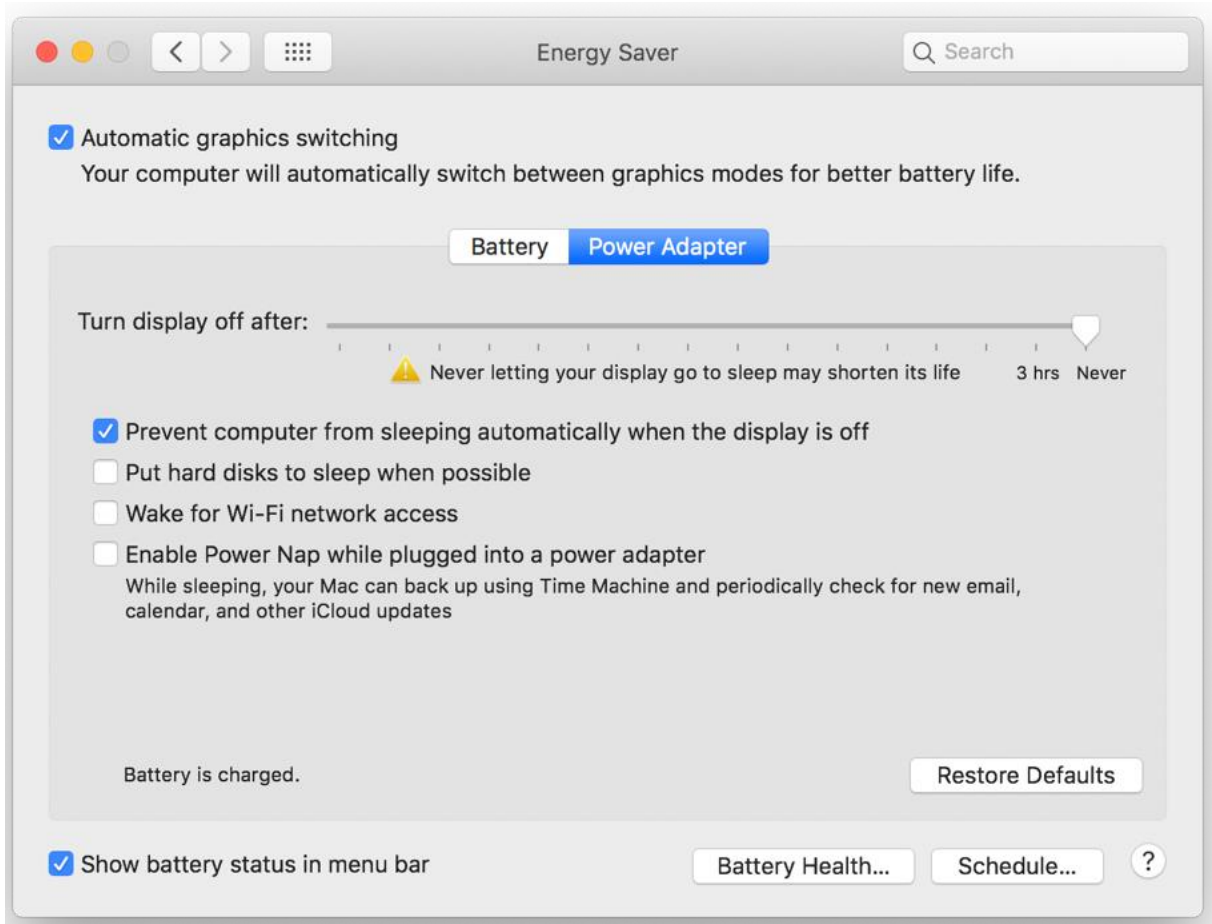


**Figure 27** Back up Windows default registry

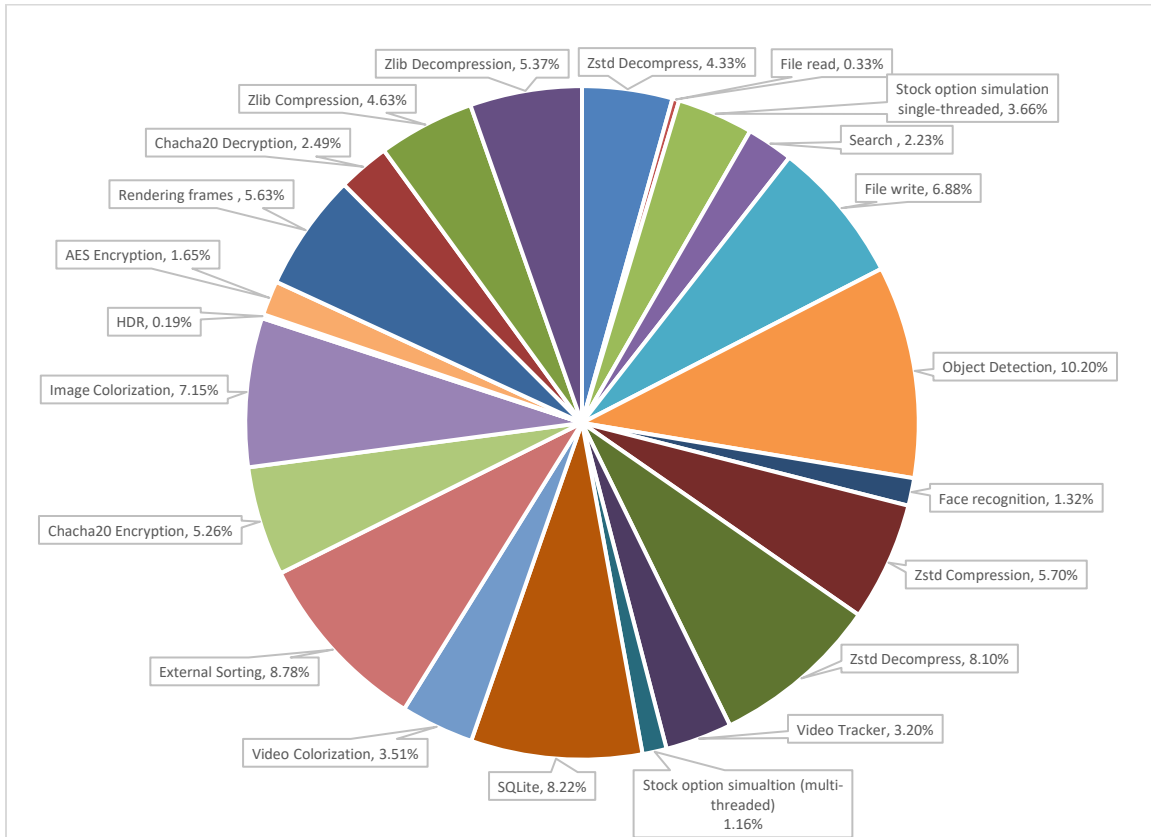


Figure 29 Overall Workload contribution

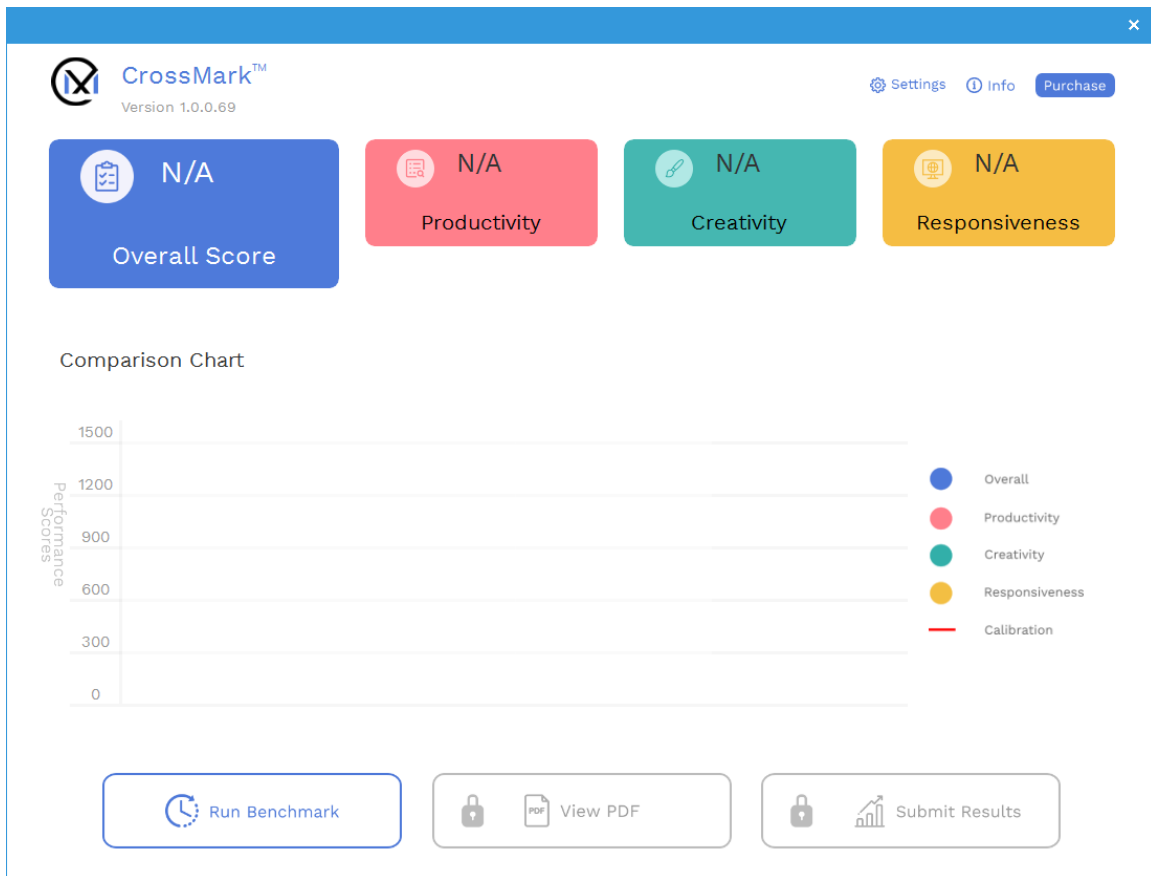



**Figure 31** CrossMark main GUI interface



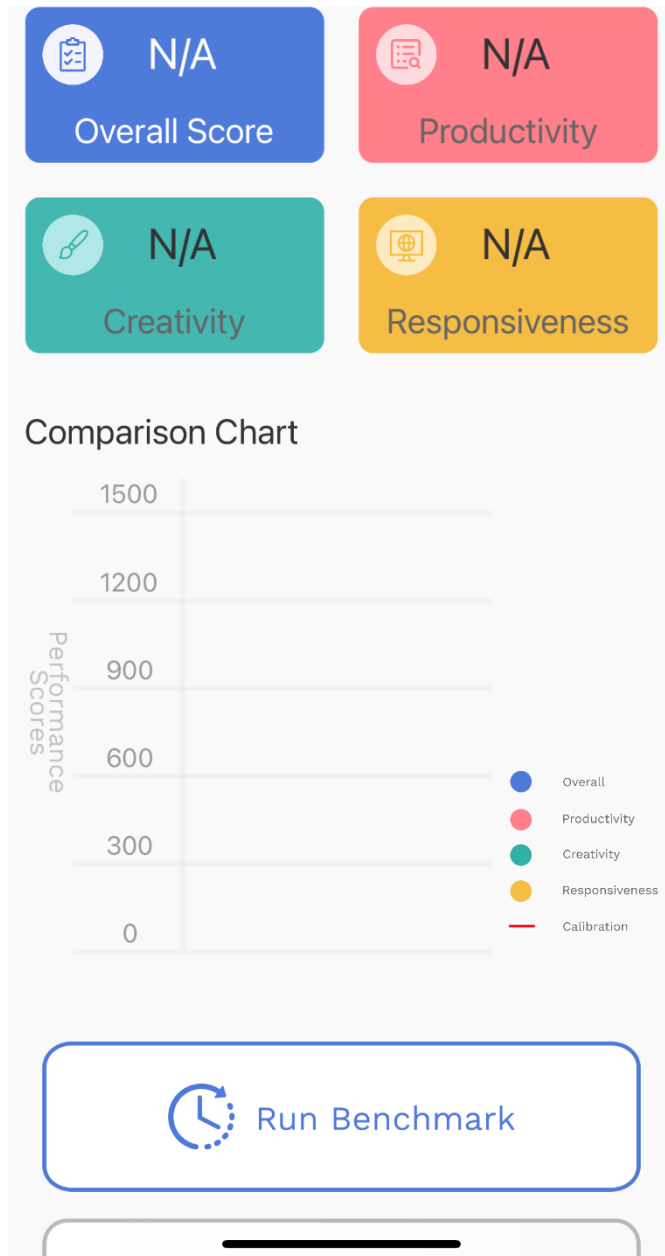



Figure 34 CrossMark main GUI interface in portrait mode
